

VOLUNTEER/OFFICIALS Pathway British Ice Skating - Short Track

This document is a guide to help anyone interested in becoming a volunteer/Official in Short Track Speed skating to understand the roles available, and the opportunities to progress in that one or more chosen role.

For anyone interested in becoming a volunteer/Official in Short Track, this document should be used in conjunction with the "BIS Volunteer Handbook" which gives more detail of what it means to be a volunteer in BIS and all the sports that come under the British Ice Skating umbrella.

How to become an Official/Volunteer

Anyone wanting to become a volunteer should contact the ST_TAC for more information and to register as a volunteer. Once registered they will be listed in the BIS _ST Regulations book.

They will remain on there until either they ask to be removed or the ST_TAC decide they no longer qualify or are inactive in that role.

The ST_TAC will administer the Volunteer/Officials Pathway and will actively seek new volunteers/Officials. The ST_TAC will monitor the Volunteer/Officials and make training available for them and assist with any courses and certification required. The ST_TAC will guide the Volunteer/Officials and provide Seminars, Training Workshops and assign Mentors for practical training where applicable.

The ST_TAC will monitor the Volunteer/Officials progress and make any promotions to higher levels based on the criteria laid out in this document. Promotions can also be requested and the ST_TAC will consider these requests after which the ST_TAC will then either make the promotion or give information as to what is still required to achieve that promotion.

Volunteer/Officials in Short Track: The Roles and Responsibilities

- > In the following sections each role will be listed with the responsibilities of that role.
- > The recommended and mandatory requirements will also be set out for each of the roles.
- ➤ If the Role has more than one level, then each will have its own criteria to meet before promotion to that level can be possible.
- > Promotion will be subject to the approval of the Short Track Technical Committee.

Timekeepers (Manual):

Level 1 (Timekeeper):

Recommended Pre-Requisites:

- ➤ To be a member of British Ice Skating (BIS)
- > To attend organised Short Track Officials seminars
- To obtain a DBS Check or equivalent (This will be valid for 3 yrs.)

Mandatory Pre-Requisites:

To be a member of BIS or of an affiliated club which has a BIS approved Code of Conduct.

Responsibilities:

- ➤ To learn the role description laid out in the latest edition of the BIS Short Track Regulations. Rule 22 paragraph 'J'
- > To attend Competitions and follow the guidance of the Chief Timekeeper and any mentor assigned to you.

Level 2 (Chief Timekeeper):

Criteria for promotion to this role:

- ➤ To fulfil all the Pre-Requisites: and Responsibilities of a 'Timekeeper'
- To be a current member of BIS
- > To have attained a competent level in the role of 'Timekeeper'
- > To have a reasonable overall understanding of the Short Track Rules.
- To have experience as a 'Recorder'. Rule 22 paragraph 'K'
- To have experience as a 'Lap Recorder'. Rule 22 paragraph 'M'

- To learn the role description laid out in the latest edition of the BIS Short Track Regulations. Rule 22 paragraph 'J', 'K' and 'M'
- > To attend Competitions and be able to fulfil the role of 'Chief Timekeeper', 'Recorder' or 'Lap Recorder' as required.
- > To perform or delegate the role of mentor, and to appoint the tasks to the team of Timekeepers at a competition.
- To attend organised Short Track Officials Seminars

Line Judge (Manual):

Level 1 (Line Judge):

Recommended Pre-Requisites:

- To be a member of British Ice Skating (BIS)
- > To attend organised Short Track Officials Seminars
- > To obtain a DBS Check or equivalent (This will be valid for 3 yrs.)

Mandatory Pre-Requisites:

> To be a member of BIS or of an affiliated club which has a BIS approved Code of Conduct.

Responsibilities:

- ➤ To learn the role description laid out in the latest edition of the BIS Short Track Regulations. Rule 22 paragraph 'I'
- To attend Competitions and follow the guidance of the Chief Line Judge and any mentor assigned to you.

Level 2 (Chief Line Judge):

Criteria for promotion to this role:

- To fulfil all the Pre-Requisites: and Responsibilities of a 'Line Judge'
- > To be a current member of BIS
- To have attained a competent level in the role of 'Line Judge'
- ➤ To have a reasonable overall understanding of the Short Track Rules.
- To have experience as a 'Recorder'. Rule 22 paragraph 'K'

- To learn the role description laid out in the latest edition of the BIS Short Track Regulations. Rule 22 paragraph 'I', and 'K'
- To attend Competitions and be able to fulfil the role of 'Chief Line Judge', or 'Recorder' as required.
- > To perform or delegate the role of mentor, and to appoint the tasks to the team of Line Judges at a competition.
- ➤ To attend organised Short Track Officials Seminars

Photo Finish Technical Operator (Electronic Timing & Photo Finish):

Level 1 (Assistant Operator)

Recommended Pre-Requisites:

- To be a member of British Ice Skating (BIS)
- > To attend organised Short Track Officials Seminars
- To obtain a DBS Check or equivalent (This will be valid for 3 yrs.)
- To have basic knowledge of computers and networking

Mandatory Pre-Requisites:

To be a member of BIS or of an affiliated club which has a BIS approved Code of Conduct.

Responsibilities:

- ➤ To have a basic understanding of the roles undertaken by 'Timekeepers' 'Line Judges' and the 'Competitors Steward', which are laid out in the latest edition of the BIS Short Track Regulations.
- ➤ To attend Competitions and follow the guidance of the Chief Technical Operator and any mentor assigned to you.

Level 2 (Chief Technical Operator):

Criteria for promotion to this role:

- ➤ To fulfil all the Pre-Requisites: and Responsibilities of an Assistant Photo Finish Technical Operator.
- > To be a current member of BIS
- To have attained a competent level in the role of 'Assistant Photo Finish Technical Operator'
- To have a reasonable overall understanding of the Short Track Rules.
- ➤ To be able to assemble the Photo Finish equipment and get it operational without guidance.

- To attend Competitions and be able to fulfil the role of 'Chief Photo Finish Technical Operator'.
- ➤ To work alongside and be able to assist with the roles of the Competitors Steward, Timekeepers and Line Judges.
- ➤ To perform or delegate the role of mentor, and to appoint the tasks to the team of level 1 Assistant Photo Finish Technical Operators at a competition.
- > To attend organised Short Track Officials Seminars

Heat Box Steward:

Level 1 (Assistant)

Recommended Pre-Requisites:

- To be a member of British Ice Skating (BIS)
- > To attend organised Short Track Officials seminars
- To obtain a DBS Check or equivalent (This will be valid for 3 yrs.)

Mandatory Pre-Requisites:

To be a member of BIS or of an affiliated club which has a BIS approved Code of Conduct.

Responsibilities:

- ➤ To learn the role description laid out in the latest edition of the BIS Short Track Regulations. Rule 22 paragraph 'H'
- To attend Competitions and follow the guidance of the 'Heat Box Steward' and any mentor assigned to you.

Level 2 (Heat Box Steward):

Criteria for promotion to this role:

- To fulfil all the Pre-Requisites: and Responsibilities of an Assistant Heat Box Steward.
- To obtain a DBS Check or equivalent.
- > To be a current member of BIS
- To have attained a competent level in the role of 'Assistant Heat Box Steward'.
- > To have a reasonable overall understanding of the Short Track Rules.

Responsibilities:

- To attend Competitions and be able to fulfil the role of 'Heat Box Steward'.
- ➤ To perform or delegate the role of mentor, and to appoint the tasks to the team of level 1 Assistant Heat Box Stewards at a competition.
- > To attend organised Short Track Officials Seminars

Lap Scorer (Both Manual & Electronic Lap Boards):

Recommended Pre-Requisites:

- > To be a member of British Ice Skating (BIS)
- > To attend organised Short Track Officials seminars
- To obtain a DBS Check or equivalent (This will be valid for 3 yrs.)

Mandatory Pre-Requisites:

To be a member of BIS or of an affiliated club which has a BIS approved Code of Conduct.

- To learn how to operate and set up both Manual and Electronic Lap Boards.
- > To learn the role description laid out in the latest edition of the BIS Short Track Regulations. Rule 22 paragraph 'L'
- > To attend Competitions and be able to fulfil the role of 'Lap Scorer'.
- To delegate the task of 'Ringing the bell' when required or get that task information from the organisers.
- To attend organised Short Track Officials seminars

Track Steward (Including Ice Maintenance):

Level 1 (Track Steward):

Recommended Pre-Requisites:

- ➤ To be a member of British Ice Skating (BIS)
- > To attend organised Short Track Officials seminars
- To obtain a DBS Check or equivalent (This will be valid for 3 yrs.)

Mandatory Pre-Requisites:

- To be a member of BIS or of an affiliated club which has a BIS approved Code of Conduct.
- > To be a competent Ice Skater

Responsibilities:

- ➤ To learn the role description laid out in the latest edition of the BIS Short Track Regulations. Rule 22 paragraph 'N'
- To attend Competitions and follow the guidance of the Lead Track Steward and any mentor assigned to you.
- > To take instruction from the Referee as to the track maintenance.
- > To be aware of all on ice safety requirements.
- ➤ Highlight Ice damage to Referees or Lead Track Steward.

Level 2 (Lead Track Steward):

Criteria for promotion to this role:

- > To fulfil all the Pre-Requisites: and Responsibilities of a 'Track Steward'
- > To be a current member of BIS
- ➤ To have attained a competent level in the role of 'Track Steward'

- To attend Competitions and be able to instruct Level 1 Track Stewards as to their role.
- To take instruction from the Referee as to the track maintenance.
- ➤ To be aware of all on ice safety requirements and ensure all the Track Stewards present are following the guidance.
- Highlight Ice Damage and advise Referee on Ice Quality.
- > To attend organised Short Track Officials seminars

Announcer / Commentator:

Recommended Pre-Requisites:

- To be a member of British Ice Skating (BIS)
- > To attend organised Short Track Officials seminars
- To obtain a DBS Check or equivalent (This will be valid for 3 yrs.)

Mandatory Pre-Requisites:

To be a member of BIS or of an affiliated club which has a BIS approved Code of Conduct.

Responsibilities:

- ➤ To make clear commentary and announcements to the Public, Officials, skaters, and support staff at a competition.
- > To make clear announcements as instructed from the Referee.
- > To be unbiased and polite in the commentary.
- > To be informed as possible about the sport, the competition and the athletes taking part.
- To attend organised Short Track Officials seminars.

Starter:

Level 1 (Starter- Domestic Competitions Only)

Recommended Pre-Requisites:

- To obtain a DBS Check or equivalent (This will be valid for 3 yrs.)
- > To have gained experience in Line Judging and Timekeeping.

Mandatory Pre-Requisites:

- ➤ To be a member of British Ice Skating (BIS)
- > To attend organised Short Track Officials seminars. (At least one in a 2-year period)

Responsibilities:

- ➤ To learn the role description laid out in the latest edition of the BIS Short Track Regulations. Rule 22 paragraph 'F'
- To have a reasonable overall understanding of the Short Track Rules.
- ➤ To attend Competitions and follow the guidance of the Chief Referee, or any mentor assigned to you.

Level 2 (Starter- Including British Championships at domestic Level):

Criteria for promotion to this role:

- > To fulfil all the Pre-Requisites: and Responsibilities of a 'Level 1 Starter'.
- > To have attained a competent level in the role of 'Level 1 Starter'.
- To have a good overall understanding of the Short Track Rules.
- To have completed at least 5 competitions at domestic level.

- To attend Competitions and be able to fulfil the role of 'Starter'.
- > To perform or delegate the role of mentor, and to appoint the tasks to other Starters at a competition.

Level 3 (Starter on the ISU International List):

Criteria for promotion to this role:

- To fulfil all the Pre-Requisites: and Responsibilities of a 'Level 2 Starter'.
- > To have been the 'Starter' at a British Championships.
- > To have attended and passed the exams at the recommended amount of organised Short Track Officials Seminars.
- To be assessed/approved by the TAC.

Responsibilities:

- To maintain the responsibilities laid out for the Official position of 'Starter' in the ISU 'Special Regulations and Technical Rules' for Short track Speed Skating.
- > To have a good overall understanding of the ISU Short Track Rules.
- To continue to support the UK Domestic competitions.

Level 4 (Starter on the ISU Officials List):

Criteria for promotion to this role:

- Promotion to this position is the sole responsibility of the ISU Technical Committee for Short Track Speed Skating.
- > Rules for maintaining this position are laid out in the ISU 'Special Regulations and Technical Rules' for Short track Speed Skating.

Competitors Steward:

Level 1 (Assistant C.S.)

Recommended Pre-Requisites:

- ➤ To obtain a DBS Check or equivalent (This will be valid for 3 yrs.)
- To be competent with working with computers and relevant software packages.
- ➤ To have some experience of Short Track Competitions.

Mandatory Pre-Requisites:

- > To be a member of British Ice Skating (BIS)
- > To attend organised Short Track Officials seminars. (At least one in a 2-year period)

Responsibilities:

- ➤ To learn the role description laid out in the latest edition of the BIS Short Track Regulations. Rule 22 paragraph 'G'
- To have a reasonable overall understanding of the Short Track Rules.
- To attend Competitions and follow the guidance of the 'Competitors Steward', or any mentor assigned to you.

Level 2 (Lead Competitors Steward including British Championships)

Criteria for promotion to this role:

- ➤ To fulfil all the Pre-Requisites: and Responsibilities of a 'Level 1 'Competitors Steward'.
- ➤ To have attained a competent level in the role of 'Competitors Steward'. To have a good overall understanding of the Short Track Rules
- To have performed to role of lead 'Competitors Steward', under guidance or otherwise, at a domestic competition.

- To attend Competitions and be able to fulfil the role of 'Competitors Steward'.
- To perform or delegate the role of mentor, and to appoint the tasks to other 'Competitors Stewards' at a competition.

Level 3 (CS on the ISU international List):

Criteria for promotion to this role:

- ➤ To fulfil all the Pre-Requisites: and Responsibilities of a Level 2 'Competitors Steward'.
- > To have been the 'Competitors Steward' at a British Championships.
- To have attended and passed the exams at the recommended amount of organised Short Track Officials Seminars.
- To be assessed/approved by the TAC.

Responsibilities:

- To maintain the responsibilities laid out for the Official position of 'Competitors Steward' in the ISU 'Special Regulations and Technical Rules' for Short track Speed Skating.
- To have a good overall understanding of the ISU Short Track Rules.
- ➤ To continue to support the UK Domestic competitions.

Level 4 (Competitors Steward on the ISU Officials List):

Criteria for promotion to this role:

- Promotion to this position is the sole responsibility of the ISU Technical Committee for Short Track Speed Skating.
- ➤ Rules for maintaining this position are laid out in the ISU 'Special Regulations and Technical Rules' for Short track Speed Skating.

Referee:

Level 1 (Assistant Referee)

Recommended Pre-Requisites:

- > To obtain a DBS Check or equivalent (This will be valid for 3 yrs.)
- ➤ To have gained some experience working in other roles at Short Track Competitions.

Mandatory Pre-Requisites:

- To be a member of British Ice Skating (BIS)
- To attend organised Short Track Officials seminars (At least one in a 2-year period).

Responsibilities:

- To learn the role description laid out in the latest edition of the BIS Short Track Regulations. Rule 22 paragraph 'A', 'B', 'C', 'D' and 'E'.
- To have a reasonable overall understanding of the Short Track Rules.
- ➤ To attend Competitions and follow the guidance of the Chief Referee, or any mentor assigned to you.

Level 2 (Chief Referee at Domestic Level):

Criteria for promotion to this role:

- ➤ To fulfil all the Pre-Requisites: and Responsibilities of a Level 1 'Referee'.
- > To have attained a competent level in the role of 'Level 1 'Referee'.
- To have a good overall understanding of the Short Track Rules.
- > To have gained experience working in other roles at Short Track Competitions.

- To attend Competitions and be able to fulfil the role of 'Ass Referee' or 'Chief Referee'.
- ➤ To perform or delegate the role of mentor, and to appoint the tasks to other Referees at a competition.

Level 3 (Chief Referee including British Championships at Domestic Level):

Criteria for promotion to this role:

- To fulfil all the Pre-Requisites: and Responsibilities of a Level 1 and 2 'Referee'.
- > To have attained a competent level in the role of 'Level 2 'Referee'.
- To have a very good overall understanding of the Short Track Rules.
- To have satisfactory experience of being a Chief Referee at domestic competitions.

Responsibilities:

- To attend Competitions and be able to fulfil the role of 'Chief Referee'.
- ➤ To perform or delegate the role of mentor, and to appoint the tasks to other Referees at a competition.

Level 4 (Referee on the ISU International List):

Criteria for promotion to this role:

- ➤ To fulfil all the Pre-Requisites: and Responsibilities of a Level 3 'Referee'.
- To have attained a competent level in the role of 'Level 3 'Referee'.
- > To have been the 'Chief Referee' at a British Championships.
- To have attended and passed the exams at the recommended amount of organised Short Track Officials Seminars.
- > To have experience of being a Heat Box Steward at a competition
- To be assessed/approved by the TAC.

Responsibilities:

- To maintain the responsibilities laid out for the Official position of 'Referee' in the ISU 'Special Regulations and Technical Rules' for Short track Speed Skating.
- To have a good overall understanding of the ISU Short Track Rules.
- > To continue to support the UK Domestic competitions

Level 5 (Referee on the ISU Officials List):

Criteria for promotion to this role:

- Promotion to this position is the sole responsibility of the ISU Technical Committee for Short Track Speed Skating.
- Rules for maintaining this position are laid out in the ISU 'Special Regulations and Technical Rules' for Short track Speed Skating.
